### ITEMIZED SELECTIONS

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

#### **PROFESSIONAL SERVICES:**

**Basic Services of Funeral Director and Staff..... \$2,275\*\***

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to initial request for services, arrangement conference with family or responsible party, arrangement of funeral, tribute or memorial service, staff to advise, assist and recommend appropriate personalization and individualization of the services to commemorate the unique life of your loved one, obtaining and recording vital statistics and biographical information for obituary notice and death certificate preparation and filing, obtaining necessary permits and authorizations, consents and assignments, coordination with other parties such as hospitals, doctor's offices, cemetery, crematory, clergy and others involved in the services and disposition. This fee also includes the temporary sheltering and care of decedent, overhead expenses relative to our facilities such as professional licensing, administrative services, maintenance, building and utility expenses, taxes, legal and accounting fees, recordkeeping, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

#### **PREPARATION:**

**Embalming..... \$750\*\***

Embalming is not required by law, except in certain cases. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**SPECIAL CHARGES:**

**Forwarding Remains to another Funeral Home ..... \$2,100**

This charge includes: transfer of deceased to funeral home, basic services of staff, embalming, necessary authorizations, and local transportation to airport. This charge does not include the use of staff and/or facilities for visitation, rites and ceremonies or any other service or merchandise not specifically listed.

**Receiving Remains from another Funeral Home ..... \$995**

This charge includes transfer of remains to funeral home, temporary shelter of remains, basic services of staff, and transportation of decedent to cemetery or crematory. This charge does not include the use of staff and/or facilities for visitation, rites and ceremonies or any other service or merchandise not specifically listed.

**Immediate Burial.....\$3,255 to \$8,605**

This charge includes the transfer of decedent to our funeral home, basic services of staff, transportation to local cemetery, and necessary permits and authorizations. The charge does not include cemetery or government fees, the use of staff and/or facilities for the visitation rites and ceremonies or any other merchandise not specifically

- A. Immediate burial with casket provided by purchaser ..... \$3,255  
(All such containers must meet any cemetery or applicable state requirement)
- B. Immediate burial with casket selected from our funeral home ..... \$3,255  
(In addition to the cost of casket)

**Direct Cremation.....\$2,475 to \$7,825**

This charge includes the transfer of the decedent to our funeral home, basic services of staff, local transportation to the crematory, necessary permits and authorizations, crematory fees, and 7 days of refrigeration. This charge does not include any government fees, the use of staff and facilities for visitation, rites, and ceremonies, or any other service or merchandise not specifically listed.

If you want to arrange a direct cremation, you can use an Alternative Container. Alternative Containers encase the body and can be made of materials like fiberboard and composition materials (with or without outside covering). The containers we provide are made of fiberboard.
